

While our "Code of Conduct" (below) lists a variety of unacceptable behaviours and processes in place to address inappropriate conduct, we expect our students not merely to comply with the "bottom line", but rather to act in a socially responsible manner and contribute positively to the school environment and community-at-large . . . and we're pleased to see countless examples of that positive school spirit at Monterey on a daily basis! In this regard, we work proactively on furthering the development of students' personal and social responsibility, with our vision in this regard encapsulated by our "STORM" acronym:

Keep <u>S</u>afe
Think <u>T</u>eam
<u>O</u>wn Your Actions
Show <u>R</u>espect
<u>Make A Difference</u>

Code of Conduct

Purpose: While we proactively foster the development of students' personal and social responsibility toward the characteristics encapsulated in our "STORM" acronym (see above for details), we also have basic expectations in order to establish and maintain a school environment that is as safe and conducive to learning as possible, free from discrimination, harassment, drugs, and violence. The following "Code of Conduct" exists to clarify these expectations as well as processes in place to address misconduct:

Expectations: Students are expected to behave in a manner that respects oneself, others, and the environment. Unacceptable conduct includes, but is not limited to:

- Behaviours that disrupt the learning environment
- Behaviours that jeopardize the safety of oneself or others
- Use of language or gestures that are offensive or inappropriate in a school environment
- Acts of discrimination, as defined by the BC Human Rights Code which, in order to "promote a
 climate of understanding & mutual respect where all are equal in dignity and rights", specifically
 prohibits discrimination based on factors such as race, colour, ancestry, place of origin, marital or
 family status, religion, physical or mental disability, age, sex, sexual orientation, or gender identity
- Wearing clothing, text, and images that:
 - Promotes drugs or alcohol, displays offensive or discriminatory language or images (see above reference to BC Human Rights Code in this regard)
 - o Potentially poses a risk to one's physical health or safety (i.e. inappropriate footwear in PE)
- Pop and caffeinated drinks (and other junk food) are discouraged, and if brought to school, must be of personal-portion size (i.e. max. 500 ml), unless for a teacher-coordinated class celebration
- Violation of our expectations regarding the use of digital technology. In that regard:
 - Unauthorized photography (including video) or posting of images/video is forbidden
 - o Online harassment (including disparaging comments to or about anyone) is forbidden
 - Purposely accessing or posting material that is inappropriate at school is forbidden
 - Personal electronic devices (as with other possessions) are brought to school at students' (and their parents') own risk of loss, theft, or damage, and the school will not be responsible for the cost of repairs or replacement

- Digital devices (i.e. computers, chromebooks, iPads, laptops, cellphones, iPods, etc.) may only be used during the school day when permitted by a supervising staff member for particular purposes, and used for those purposes only
- At all other times, "pocket-sized" devices (i.e. cell phones, iPods, etc.) must be off (e.g. no sounds) and locked in the student's own locker*
- Theft or damage to property, including graffiti
- Possession of weapons, alcohol, tobacco (including e-cigarettes or vaporizers), or drugs, or being
 at school under the influence of any amount of alcohol or drugs, or selling or distributing any of
 these items to any students within our school community
- Acts of harassment, intimidation, or physical violence
- Lying to a staff member
- Noncompliance with direction from staff member to go to a specific location (i.e. office, hall, etc.)
- Being a "bystander" to significant misconduct that is, being present in a manner that actively or
 passively supports or encourages conduct that is unsafe, illegal, or harmful to people or property
- Words of hostility and/or threats or acts of retaliation toward anyone reporting a concern
 - o note that asking, telling others, or making comments about those reporting misconduct will be considered a form of retaliation

While the above list states a number of unacceptable behaviours, we expect our students *not* merely to comply with the "bottom line", but rather to act in a socially responsible manner and contribute positively to the school environment and the community-at-large, with older students demonstrating increased maturity and providing a good example to younger students.

Consequences: When addressing inappropriate behaviour, we generally provide students with opportunities and guidance to take responsibility for their actions, fix and learn from their mistakes, and resolve issues in a constructive manner. In determining the consequences for violations of our code of conduct – ranging from community service, mediation, and problem-solving conversations, to confiscation and/or restriction of items at school, to behavioural goal-setting and/or tracking logs, to detentions and/or loss of permission to participate in a special activity/event/fieldtrip/etc., to various tiers of suspension – the nature, severity, and frequency of a student's misconduct, individual factors relevant to that student (i.e. maturity, personal/family circumstances, special needs, etc.), and the student's level of constructive engagement in restorative processes and collaborative problem-solving, are all taken into consideration.

Notification: Depending on the nature, severity, and frequency of the behavioural concern(s), school personnel may notify a student's parents/guardians of incidents of misconduct by telephone, email, or other means. School administration will inform send a formal letter to a student's parents/guardians and the Associate Superintendent regarding any out-of-school suspensions. Police and/or other agencies will be notified of known or suspected misconduct as required by policy or law, or if their involvement is deemed by school administration to be warranted in addressing an incident or concern.

*Parents/Guardians: If you need to communicate with your child during the school day (i.e. to check-in or make logistical arrangements), please refrain from calling/texting your child directly; rather, if you have a message for your child, please contact the school office at 250-598-4589. Conversely, students wishing to contact their parents or others during the school day are expected to seek permission from a staff member to do so on a school phone rather than using a personal electronic device during the school day. In general, we ask that you make your arrangements in advance of the school day or after school, so that student routines are not interrupted during the school day and our middle school youth further develop their organizational skills and independence.
